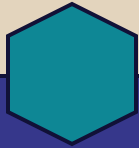

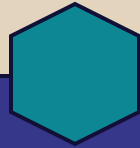

The Growing Challenge of Registry Integrity

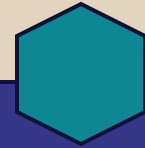
Number Resource Policy Manual (NRPM) 4.10
and 4.4 space provides an attractive target



Fraudulent activities targeting the ARIN registry have escalated, including identity theft and hijacking



Increased attempts to create Org IDs by registering companies using registered agents and requesting IPv4 resources



These fraudulent activities threaten registry accuracy and community trust

Our Commitment to Registry Integrity



Maintaining the registry's accuracy and fairness is central to ARIN's mission

Resource fraud and abuse impacts everyone in the ARIN community

ARIN is proactively taking steps to address and prevent misuse



Formation of the RIO Team

New Registry Integrity and Oversight team established under the Chief Experience Officer and led by Reese Radcliffe

To focus specifically on addressing fraud, policy abuse, and integrity-related concerns

Actions Taken – ARIN updated Org Create Procedures

- Introduced procedures for flagged Org Create requests that require additional validation.
- Video verification is used to confirm identity, authority, and organization legitimacy prior to RSA signature.
- *Government photo ID is required.*
