Description

- If then 2007-9 is adopted, then 2007-10 establishes the immediate need policy for end-users. The minimum assignment would be the ARIN's minimum assignment as defined elsewhere in the NRPM, and the maximum would be a /16. Also defines a 30 day utilization window of the IP address space. If 2007-9 is not adopted, then 2007-10 requires replicating the text from the existing ISP Immediate Need policy into the end user section of NRPM.
