Voting Procedures

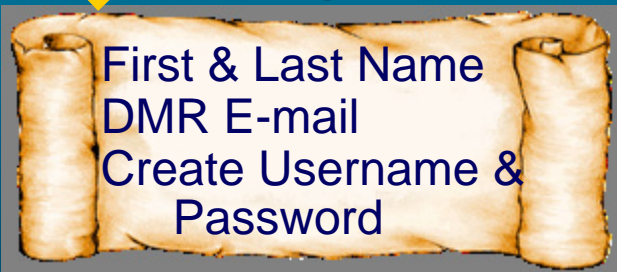
- Only designated member representatives (DMRs) from ARIN General Members in good standing may vote

 - ➔ E-mail account must include the DMR's name or initials and the organization's domain name
- Friday, 13 October:
 - ➔ Election Headquarters URL and instructions sent to eligible DMRs
 - ➔ E-mail reminder to arin-announce

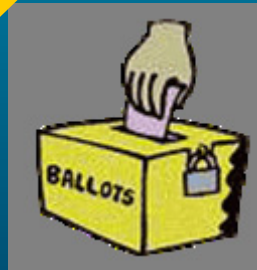

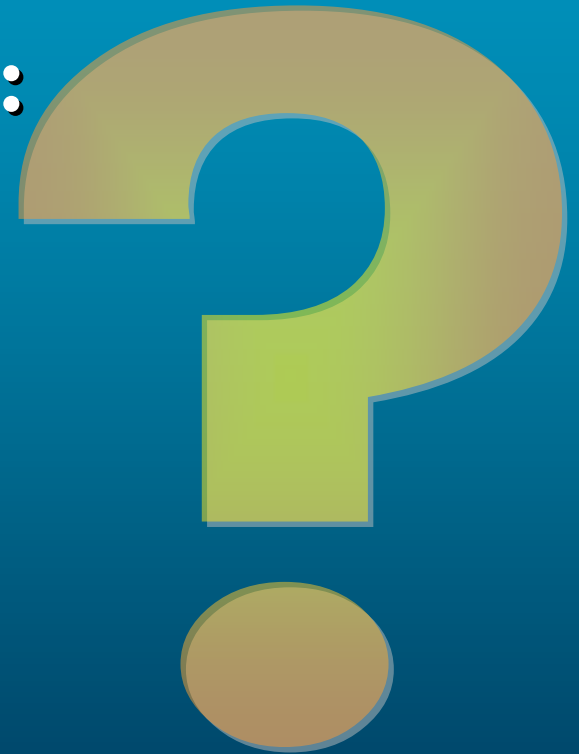
