WHAT ARE WE CURRENTLY BUSY ON?

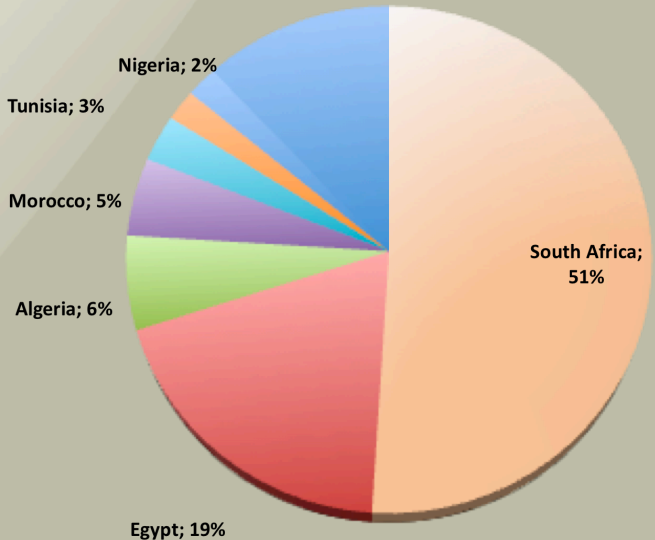
- **Improve communications** with non-conventional stakeholders (governments, civil society, Mobile Operators, Regulators etc...)

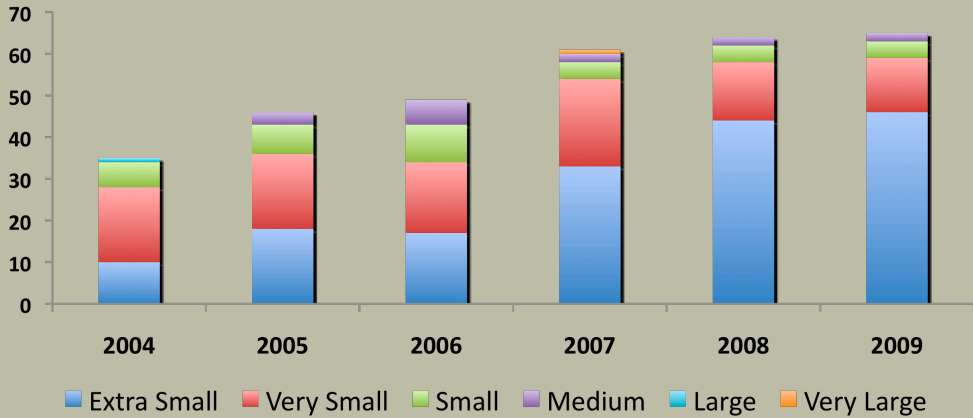

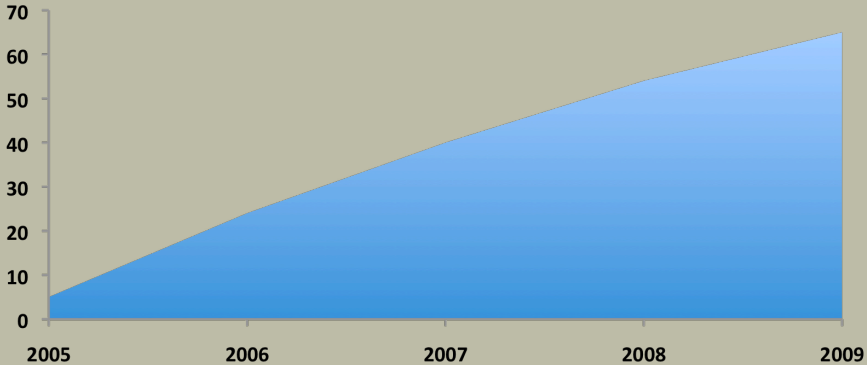
IPv4 Addresses by Economy



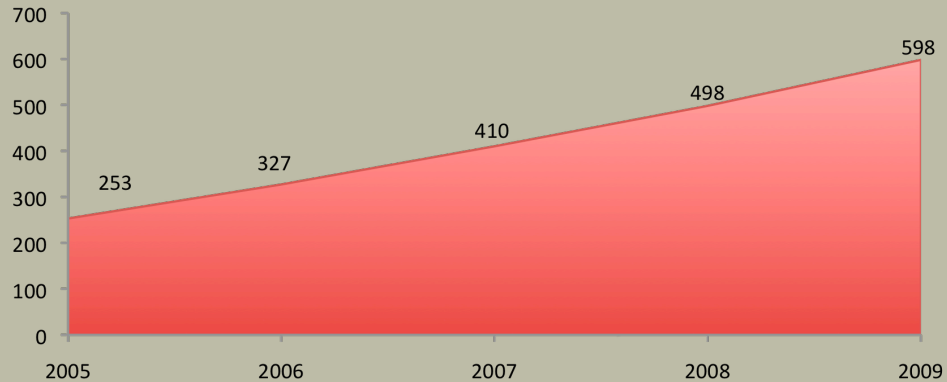
Distribution of LIR Members by Size (or Billing Category)
