## FREQUENTLY ASKED QUESTIONS

### When can I vote?

Designated member representatives from General Members in good standing can vote from **3:00 PM ET on 6 October** and **3:00 PM ET on 16 October**.

### Am I eligible to vote in the Board and Advisory Council election?

Yes, if you are a designated member representative (DMR) from an ARIN General Member in good standing that has joined prior to 1/1/10.

### I need to update my DMR record or change the DMR associated with my organization.

#### How do I do this, and can I still vote?

To be eligible to vote in the 2010 ARIN elections, any DMR changes needed to be made by 21 September. However, you can change or update your DMR at anytime. Email [info@arin.net](mailto:info@arin.net) and provide the name and personalized email of the person you wish to designate.

### My organization is an ARIN member. Is it in good standing?

To be considered in good standing, your organization must not have any outstanding invoices. To check your organization's billing status, please email [billing@arin.net](mailto:billing@arin.net). As previously announced, organizations must be in good standing as of 21 September to be eligible to vote in the 2010 ARIN elections.

### When will the results be announced?

The Board and Advisory Council results will be announced via email to the arin-announce mailing list and on the ARIN website on 22 October.

### Who is my organization's designated member representative?

Visit ARIN's Help Desk or email [info@arin.net](mailto:info@arin.net) to identify your organization's DMR.

## HOW TO VOTE

### This is my first time voting in an ARIN election.

#### What do I do?

The online election system requires you to register and confirm your account before voting.

- 1 **Go to Election Headquarters at <https://www.arin.net/app/election/>**
- 2 Click "Vote Now"
- 3 Complete the Voter Registration Form and enter validation code presented
- 4 You will receive a confirmation email, click the link
- 5 Enter your Username and Password to login
- 6 Select and answer two challenge questions, these will be used to identify you if you need to recover your username for future elections
- 7 Select an election and proceed to the ballot to cast your vote
- 8 You must confirm your vote when prompted, only confirmed votes will be counted

### I voted in a previous ARIN election. What do I do?

- 1 Go to Election Headquarters at <https://www.arin.net/app/election/>
- 2 Click the "Vote Now" button and login
- 3 Select an election and proceed to the ballot to cast your vote
- 4 You must confirm your vote when prompted, only confirmed votes will be counted

### I forgot my username. How do I recover it?

- 1 Go to Election Headquarters at <https://www.arin.net/app/election/>
- 2 Click "Vote Now," and select "Trouble Logging In"
- 3 Enter your DMR email address under "Forgot Username" and the validation code presented
- 4 Answer challenge question presented and click "Recover"
- 5 An email will be sent to you containing your Username

If you were not required to answer challenge questions as part of the registration process, you will need to email [info@arin.net](mailto:info@arin.net) or visit the Election Help Desk for your Username.

### I forgot my password. How do I recover it?

- 1 Go to Election Headquarters at <https://www.arin.net/app/election/>
- 2 Click "Vote Now," and select "Trouble Logging In"
- 3 Enter Username, your DMR email address under "Forgot Password", and the validation code presented
- 4 You will be emailed with instructions to reset your password

### What email address should I enter when I register to vote?

Designated member representatives (DMRs) for ARIN member organizations should enter the DMR email address on file with ARIN's Member Services department.
